Phase II Bond Projects ~ Concept Design Meeting ~ September 29, 2023

An informational meeting was held for the Westside Community Schools Board of Education on Friday, September 29, 2023, at 12:00 p.m. at the District Administration Office - ABC Building - 909 S. 76th Street, Omaha, Nebraska. This meeting was only for the purpose of sharing preliminary design concepts for the Westgate Elementary School Phase II Bond project. No official business was conducted.

Notice of the meeting was given by placing advance notice on the front page of the District's website no less than 48 hours in advance of the scheduled commencement of the meeting as authorized by Board Policy 1220. Notice for this meeting appeared beginning on September 27, 2023, and appeared continuously up through the start of this board meeting. Notice of the meeting was also published in the Daily Record on September 29, 2023, and on their website. Notice of this meeting and the availability of the agenda was simultaneously given to all members of the Board of Education and available to anyone at the Board of Education office. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Mr. Matt Herzog with Project Advocates confirmed that public notice had been given of the meeting under the Nebraska Open Meetings Act and that a copy of the Nebraska Open Meetings Act was posted at the meeting and on the district website, as required by law, and the agenda was available to any interested parties. Board member attendance is noted above.

Representatives from TACK Architects presented preliminary concept designs for the new Westgate Elementary School. Numerous design concepts, building site options, and other elements such as learning spaces, community spaces, safety and security, pick-up and drop-off, and the playground area have been considered at a number of meetings involving the Westgate Design Advisory Committee (staff, parents, Project Advocates and district leadership), as well as with the Westgate neighborhood. The current concept design is a single-story building with a public wing (main entrance and offices, cafeteria, gymnasium) and secure classroom wing and will be set back along the northern edge of the district property line. This will allow for a substantial pick-up and drop-off traffic lane.

Board approval of the Concept Design for Westgate Elementary is scheduled for the October 2, 2023, Board of Education Meeting.


