Phase II Bond Projects ~ Concept Design Meeting ~ November 3, 2023

An informational meeting was held for the Westside Community Schools Board of Education on Friday, November 3, 2023, at 12:00 p.m. at the District Administration Office - ABC Building - 909 S. 76th Street, Omaha, Nebraska. This meeting was only for the purpose of sharing preliminary design concepts for Phase II Bond projects at Westside High School and the ABC Building (District Office). No official business was conducted.

Notice of the meeting was given by placing advance notice on the front page of the District's website no less than 48 hours in advance of the scheduled commencement of the meeting as authorized by Board Policy 1220. Notice for this meeting appeared beginning on October 24, 2023, and appeared continuously up through the start of this board meeting. Notice of the meeting was also published in the Daily Record on November 2, 2023, and on their website. Notice of this meeting and the availability of the agenda was simultaneously given to all members of the Board of Education and available to anyone at the Board of Education office. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Mr. Matt Herzog with Project Advocates confirmed that public notice had been given of the meeting under the Nebraska Open Meetings Act and that a copy of the Nebraska Open Meetings Act was posted at the meeting and on the district website, as required by law, and the agenda was available to any interested parties. Board member attendance is noted above.

Mr. Matt Smith with BVH Architecture presented the Concept Design for the Westside High School restrooms and locker rooms renovation project. He reviewed key design goals identified by the Design Advisory Committee for both restrooms and locker rooms that include: updated layouts and finishes; safety and security; durability of fixtures; ease of maintenance; and ADA and Title IX compliance. Mr. Smith also reviewed a phased construction schedule to ensure that there will always be a restroom facility available for use on each floor of the building during construction, which will be done during summer breaks in 2024, 2025, 2026 and 2027.

Mr. Matthew Erion with BCDM Architects presented the Concept Design for the ABC Building renovation project. He reviewed meetings that have been held to date with the ABC Design Advisory Committee and the design concept priorities that came from those discussions. In addition to the bond priorities of HVAC renovations and ADA accessibility, the DAC also felt strongly about the overall visitor experience and impression of the District office. Mr. Erion presented concept design ideas for a renovation of the main entry level of the ABC Building that would expand the Welcome Center and reconfigure the board room and restroom spaces. He also reviewed the impact of the renovations on each level of the building, since staff will remain in the building during the entire project. Some temporary relocations of various departments will be necessary due to the location of HVAC ductwork.

Board approval of the Concept Designs for the WHS restroom and locker room project and the ABC Building renovation project is scheduled for the November 6, 2023, Board of Education Meeting.
